We are in still in winter but Mother Nature has teased us with some spring-like days. This time of year entices our cleanup mood which ends up with unwanted items. We will gladly help direct you to the appropriate area to place your items. Remember fees apply to some items. Check your items with the scale house attendant. As of this time the Still Good Shed is not operational but it is progressing. Volunteers are need please contact Sandy LaFleur at strumma@aol.com.

New red stickers are now available (see attendant)! Vehicle registration is required for recording your information. A new sticker will be given only to the vehicle that is present. Please apply the new sticker before leaving; we can also help you remove the old sticker.

The Household Hazardous Waste Day will be **Sunday June 26, 2022** from 9:00 a.m. to 1:00 p.m. The information flyer with the form on the back will be available online and at the recycling center in the near future, so watch for it. Please read the flyer before coming to know what is accepted and what is not. Fill out the form on the back of the flyer before coming. This event will be basically be set up the same as last year You must have a current new red sticker on your vehicle to participate. No stickers will be given on that day and no trash will be accepted.

Take Notice: New Hours starting April 15, 2022 for Tuesday and Thursday:

Tuesday: NEW 7:00 a.m. to 5:00 p.m. (was 6:30 a.m. to 4:30 p.m.) Thursday: NEW 10:00 a.m. to 7:00 p.m. (was 11:00 a.m. to 8:00 p.m.)

On Thursdays we will be leaving the premises promptly at 7:00 p.m. so please have your visit completed by closing time.

A few reminders:

Demolition/Construction debris along with landfill trash including items from clean outs (bedrooms, garage, shed, attic etc.) must be checked in at the scale house. Fees apply to some items which will be determined by the scale house attendant. Remember you must go all the way around to weigh-out on the scale. This is a one way driveway. Fees apply to all electronics (see scale house attendant).

All fluids must be drained from items before placing them in the metal container. We had a gas tank with 10 gallons of gasoline in it placed in the metal container, so now we have 10 gallons of hazardous waste which will be a cost to us. We cannot take used oil that is contaminated so please check the condition of your oil before bringing it in. If it is contaminated you can bring it to the hazardous waste collection day.

We do not accept smoke alarms, but we have information on where to send them back to the manufacturer or you can bring them to the hazardous waste collection day.

We now have a new clothing collection shed, St. Pauly Textile, Inc. and the participation has been tremendous. Please have all items in a closed bag. Thank you for your support.

Please do not enter the facility when the CLOSED and No Trespassing signs are showing at the gate. Drive slowly when coming in or out of this nice flat, smooth, long driveway. There are vehicles and people constantly in motion.
